To receive a free *DIY Health Toolbox*, a Men's Shed must meet the following eligibility criteria:

- It is overseen by a not-for-profit community-based organisation¹ that is socially inclusive and opens its doors to all males wishing to participate in Shed activities, OR conforms to the above definition in all respects except that its membership is restricted to male Aboriginal and Torres Strait Islander members for cultural purposes; AND
- The primary activity is the provision of a safe, friendly and inclusive environment where males are able to gather together and/or work on meaningful projects at their own pace, in their own time and in the company of other males; AND
- It is a purpose built facility, or a multi-purpose community or private building, used on a regular basis as Men's Shed for the primary activity detailed above, AND the group identifies its primary purpose as being a 'Men's Shed', OR in the absence of a purpose built facility, identifies as a gathering for the purposes of men's business in Aboriginal or Torres Strait Islander groups.
